Stäubli Is Named Official Provider Of Dry Break Coupling Kits for USF2000

PALMETTO, Fla., Feb. 15 — Stäubli has been named the official provider of mandatory dry break coupling kits for the USF2000 National Championship, which is presented by Cooper Tires and powered by Mazda.

Stäubli dry break couplings are an important safety measure. Located between a USF2000 car's fuel cell and its fuel-injection intake and tethered to the frame, they are designed to separate in a large impact. Once separated, the dry breaks will help prevent any major fuel spills that could ignite.

Stäubli dry breaks are also a 'green' initiative because they act as a clean, nospill connection for the series' tech officials conducting fuel samplings.
