VIR Policies & Procedures for ALMS Participants

Alcohol - Beer and wine are available for sale at our concession stands. Beer in coolers is permitted for individual consumption.

Asphalt - Do not pound stakes or make any holes in any asphalt surface. Do not paint <u>any</u> asphalt surface. Offenders will be held liable for all damages and may be ejected. Do not fuel cars on paved areas, except as permitted on pit road during racing competition. Any fuel spills on pit road must be immediately diluted with Cold Fire. If you must temporarily jack a vehicle on asphalt, you must have metal or wood under the jack and jack stands. NO EXCEPTIONS!

Bicycles - Children under 16 are prohibited from riding bikes, roller blades, skates, skateboards and scooters in the paddock during hot track hours. Children may be permitted to ride them at the end of the day if they do so safely.

Camping - RV Parking in the North Paddock is to be arranged through Mike Simons at IMSA: 706-658-2120 Ext. 265 or <u>msimons@imsaracing.net</u>. Cost is \$500 per Premium RV spot with full hookups (water, sewage and electricity). North Paddock RV parking spaces without hookups will be \$300 each. Additionally, there will be limited General RV spots outside the paddock available at \$200 per weekend. To reserve General RV spots, contact Tammy Journigan 434-822-7700, Ext 101, or <u>tjournigan@VIRnow.com</u>.

Campfires - Campfires/Ground fires are not allowed. Fires must be contained in a portable and approved fire pit. Use of VIR Property as fire wood is prohibited.

Cars & Motorcycles – No one under 16 years of age may operate a car or motorcycle anywhere on VIR premises without VIR's prior written approval. In addition, anyone operating a car or motorcycle must have a valid operator's license and liability insurance, as required by Virginia law. There may be special exceptions to this rule for licensed racers and the Renter must notify VIR should it seek such an exception.

Children - Children under 18 years of age must be closely supervised by a responsible adult.

Cook Outs - Individual cooking is allowed on a gas stove or on a grill in the Paddock and at camp sites. Grills and pit cookers cannot be used to feed Participants or friends at an Event.

Disposal of Waste Fluid and Environmental Debris - Use of the waste drums is mandatory for used oil, antifreeze, brake fluid, and other polluting material. Spillage will not be tolerated and may result in ejection from the facility. Participants must remove all used tires, batteries and unwanted parts. Environmental debris left behind will result in fines to the Renter. Please refer to the attached North Paddock Utilities Map to locate the various Safety Kleen stations.

Fences - Do not climb fences or enter areas behind spectator fences without obtaining permission from VIR security or emergency personnel. Fence jumpers will be asked to leave the property.

Fireworks - Fireworks are prohibited anywhere on the grounds.

Fuel – The following octanes are available at the fuel island in the North paddock for <u>credit card</u> <u>purchase only</u>: 93 unleaded which may contain up to 10% ethanol, 100 unleaded which may contain up to 10% ethanol, 110 leaded which is ethanol-free, and 112 leaded which is ethanol-free.

Gate Hours - The main gate is generally open 24 hours.

Golf Carts – Teams wishing to rent golf carts for this event are asked to visit <u>www.golfcarcompany.com</u>

and click on Reservations to complete the application form. Alternately, teams can contact The Golf Car Company direct at 800-589-8833 or by emailing <u>reservations@golfcarcompany.com</u>. Advance reservations

are strongly suggested. Off-Road Vehicle Passes are not required for rental carts.

Karting - VIR has on-site a 1/20-mile paved banked oval as well as a 5/8-mile paved natural terrain go-kart road course and 9hp go-karts. For information about renting the go-karts for your group, contact Patrick Eagan at 434-822-7700 x350.

Music - Please be considerate of neighbors; do not play loud music.

Off-Road Vehicle Policy - VIR will provide one Off-Road Vehicle Pass per team at no charge. However, all other off-road vehicles must be registered and stickered by VIR for use in the paddock. Teams must fill out the 2012 Season Pit Vehicle Registration and Agreement form in advance and make payment through Pay-Pal at a cost of \$25 per vehicle: <u>http://virnow.com/files/2011/11/OFF-ROAD-VEHICLE-REGISTRATION-AGREEMENT-2012-Season.pdf</u>. Deadline for on-line registration is September 7th. You must have an Off-Road Vehicle Pass to operate the vehicle on VIR property or it will be impounded. Vehicles licensed for the road do not need to go through this process.

Pets - VIR discourages bringing pets to the track. Pets will be allowed if they are leashed and cleaned up behind. Otherwise, VIR will locate the owner and both will be asked to leave. Do not take leashed pets onto False Grid or pit areas. Pets are also not allowed in any of VIR's buildings or concession areas.

Pit Wall – Painting or writing on pit lane and pit wall is prohibited.

Photography – All non-commercial photography is allowed at VIR for Public Events. If there is a Private Test at VIR, all photography rights are suspended unless there is written permission from VIR. If a member of the media or a professional photographer needs photography credentials, they should contact Crista Walker at least 2 weeks prior to event at 434-822-7700 x116, or <u>cwalker@VIRnow.com</u>.

Restaurant - VIR offers a full service restaurant and bar within our 1840s plantation house. The Oak Tree Tavern is open for dinner 7 days a week starting at 5:30 p.m. Connie's Pub opens at 5:00 p.m. daily. Reservations are encouraged: 434-822-8605.

Shipments - Renter is responsible for shipments to VIR by its Participants.

Showers - The showers are located in the North Paddock main concession building restrooms, at the North Paddock grid barn, just outside the North Paddock entrance, and the South Paddock tech shed. Please be considerate regarding water use and do not waste water in any way.

Smoking - Smoking in VIR's buildings is strictly forbidden and will not be tolerated. Please place all extinguished cigarettes in the receptacles provided. Smoking is not permitted inside the "hot" fence of the track or on pit lane.

Speed Limits - Speed limit in the paddock is 15 mph. Speed limit on access roads is 25 mph. Do not test vehicles or bed brakes on infield roads.
