All carts, scooters and other similar motorized vehicles driven on site must be pre-registered and require a permit, whether owned or rented. Any vehicle on site without proper permit is subject to impound at owner's expense. Permits for approved users will be distributed and/or available for pick-up at the *Credentials Center located at the Hilton Hotel* on the corner of 4th Avenue South and 2nd Street South.

In order to reserve your permit, the following documents must be completed and submitted by Wednesday, March 13, 2013:

- Completed and Signed Motorized Vehicle Registration Application (attached)
- Certificate of Insurance, as per application
- Payment of \$25.00 US via credit card or check payable to Honda Grand Prix of St. Petersburg

Note: any application after Wednesday, March 13, 2013 is subject to an additional \$25.00 fee.
